

## NOTICE: READ BEFORE SIGNING

This waiver, release of liability, and indemnity agreement limits Your rights to the recovery of damages in connection with your attendance or participation in the Recreational or Sporting Activity identified below. "You" or "I" as used herein includes the Participant and/or the minors listed below.

### WAIVER, RELEASE AND INDEMNITY AGREEMENT

I, the undersigned, hereby acknowledge that I have voluntarily applied to participate in, or act as a spectator of, the recreational and/or sporting activity listed below sponsored by The Reynolds and Reynolds Company and/or its affiliated companies, and their employees, officers, directors, and agents (collectively, "Reynolds").

I am aware that my participation in, or observance of, the recreational and/or sporting activity listed below is a potentially hazardous activity, yet I am voluntarily participating in, or observing, such with the knowledge of the danger involved, and hereby agree to voluntarily accept any and all risks of injury and death.

As lawful consideration for being permitted to participate in the recreational and/or sporting activity as a guest of Reynolds, I hereby agree that I, my heirs, distributes, guardians, legal representatives, and assigns, will not make a claim against, sue, attach the property of, or prosecute Reynolds for personal injury, death, or property damage, including such that may result from negligent acts or omissions, including the negligence of Reynolds.

In addition, I hereby RELEASE and DISCHARGE Reynolds from all actions, claims, or demands including, but not limited to, any action, claim or demand for workers' compensation benefits under Title 5 of the Texas Labor Code, I, my heirs, distributes, guardians, legal representatives, or assigns, now have or may hereafter have, for personal injury, death, or property damage while on or about the premises provided and/or paid for by Reynolds for the recreational and/or sporting activity, even if caused in whole or in part by the negligence of Reynolds.

I, further, agree that I shall indemnify and hold Reynolds harmless from and against any and all claims, damages, losses, and expenses, including any litigation expenses, arising out of, or resulting from, my participation in the recreational and/or sporting activity.

In the event that I suffer an injury or property damage at the recreational or sporting activity, I acknowledge that I am to report said injury or property damage to Reynolds' event coordinator as soon as reasonably possible after the injury or property damage has occurred, and in no event later than 7 days after the occurrence thereof.

I acknowledge and agree that this Waiver, Release, and Indemnity Agreement shall remain in full force and effect from the date of execution until the completion of the recreational or sporting activity (i.e. if a seasonal event, for the entire season). I, further, acknowledge and agree that this Waiver, Release, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Texas, and that if any provision hereof is held invalid, it is agreed that the remaining provisions shall, notwithstanding, continue in full force and effect.

I acknowledge and agree that I have carefully read this Waiver, Release and Indemnity Agreement and fully understand its contents. I am aware that this is a release of liability between Reynolds and me, and I have signed it of my own free will.
